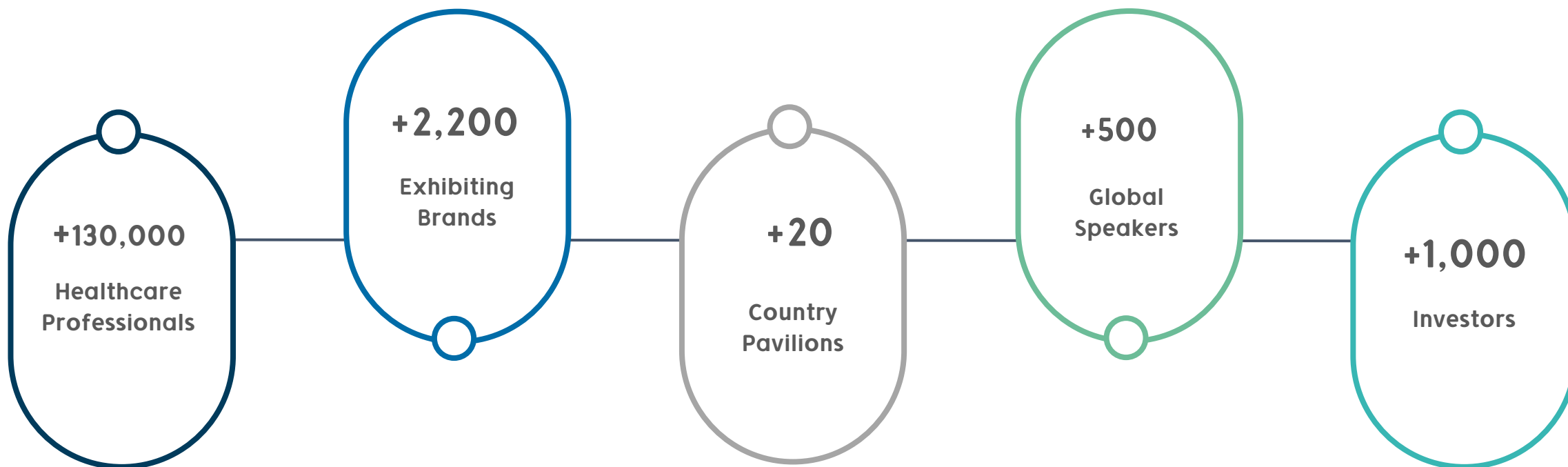

Approved submissions receive guidance on announcement or signing requirements.

Bring the agreement to life at Global Health Exhibition 2026.

Early Registration

Early registration is recommended to secure your preferred dates and times in advance, as available slots may be limited closer to the event.

We recommend completing registration before October 11, 2026, as registration will close after this date.

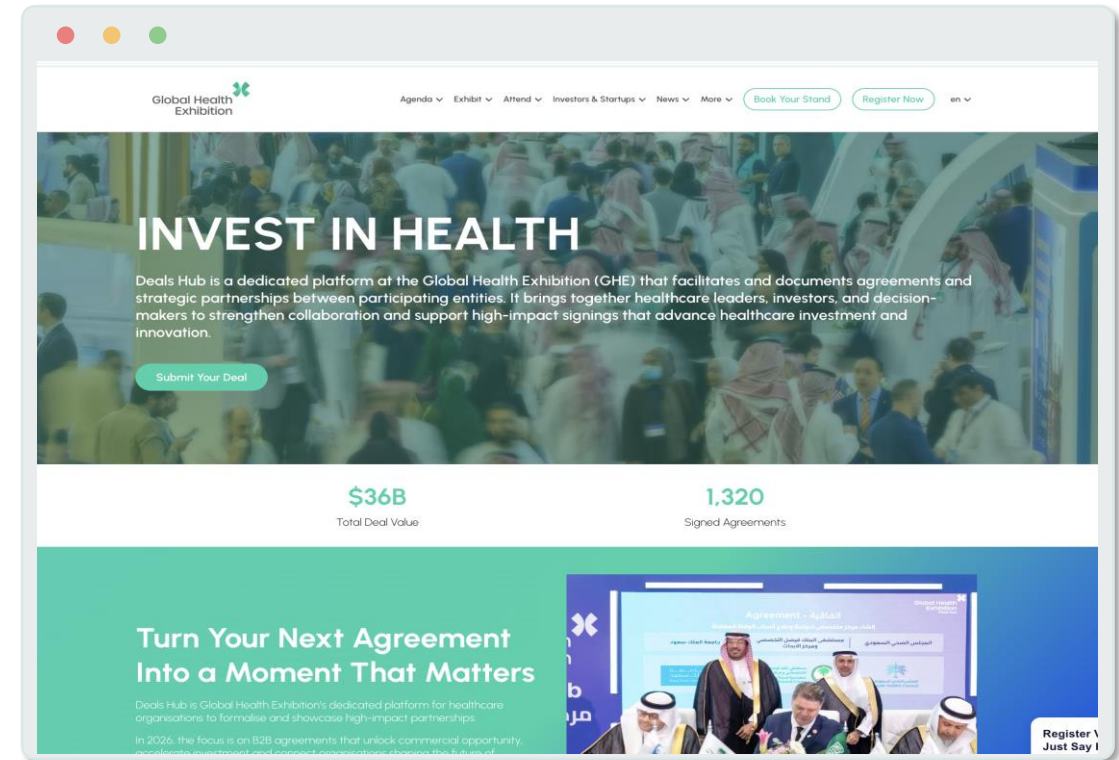

To ensure all documents and agreements signed during the Global Health Exhibition are tracked and documented, we ask anyone planning to sign a document –including signings that take place inside exhibitor stands outside the Deals Hub –to follow these instructions:

Financial Value & Expected Impact

Please include the estimated financial value or expected financial impact of the document, whether direct or indirect, to support documentation, follow-up, and impact measurement.

Adding a Third Party

If the document involves three or more parties, additional parties can be added within the document details.

Coordination Contact

Designate a coordinator to liaise with all relevant parties, ensure the documents are ready and accurate, avoid duplication, and confirm attendance at the signing appointment for a smooth process.

Register All Documents and Agreements

Please register all documents and agreements planned to be signed during the exhibition, including those signed at exhibitor booths, to ensure complete tracking and documentation.

Signing at the Exhibitor stand

If you choose to sign at the exhibitor booth, registration is limited to tracking and documentation only, without the option to book a signing appointment through the platform.

Accuracy of Data & Titles

Please make sure all entered information is accurate, especially the names and titles of entities and parties.

Upload Entity Logo

Please upload the entity's logo in PNG format, with high quality and clarity, to ensure it displays clearly on screens during the signing ceremony.
